# Cation- $\pi$ and hydrophobic interaction controlled PET recognition in double mutated cutinase – identification of a novel binding subsite for better catalytic activity†

Accelerated hydrolysis of polyethylene terephthalate (PET) by enzymatic surface modification of various hydrolases, which would not degrade the building blocks of PET in order to retain the quality of recycled PET, is a promising research area. Many studies have been reported to identify mutations of different hydrolases that can improve PET degradation. Recently, the mutation of glycine and phenyl alanine with alanine in cutinase was found to improve the activity of PET degradation 6-fold. Yet, a deep insight into the overall structural basis as well as the explicit role played by the amino acid residues for PET degradation is still elusive, which is nevertheless important for comparative analyses, structure–function relations and rational optimization of the degradation process. Our molecular dynamics simulations coupled with quantum mechanical study demonstrate that mutations of anchor residue phenyl alanine to alanine at the PET binding cleft of cutinase unveiled a distal yet novel binding subsite, which alters the nature of dispersive interaction for PET recognition and binding. The phenyl alanine engages in  $\pi$ - $\pi$  interaction with the phenyl ring of PET ( $-8.5 \text{ kcal mol}^{-1}$ ), which on one side helps in PET recognition, but on the other side restricts PET to attain fully extended conformations over the entire binding cleft. The loss of  $\pi$ - $\pi$  interaction due to mutation of phenyl alanine to alanine is not only compensated by the favourable cation- $\pi$  and hydrophobic interactions from the arginine residues ( $-17.1 \text{ kcal mol}^{-1}$ ) found in the newly discovered subsite, but also favours the fully extended PET conformation. This subsequently impacts the overall increased catalytic activity of mutated cutinase.

## Introduction

Polymeric esters of terephthalic acid or PET, which is a polyester comprising terephthalic acid (TPA) and ethylene glycol (EG) linked *via* ester bonds, constitute a good portion of the plastics industry due to their massive production at low cost.<sup>1–4</sup> The chemical structure of these plastics makes them durable and in turn also resistant to natural processes of degradation,<sup>5</sup> meaning harsh chemical conditions as well as high temperature are required to degrade them.<sup>6,7</sup> Hence, they are a potential threat to human health.<sup>8</sup> However, it is nearly impossible to replace plastics with other materials throughout the various industries. Therefore, it is essential to adopt the concept of reduce, recycle and reuse for a sustainable future, but not much recycling and reuse happens.<sup>9</sup> PET has hydrolysable ester

bonds, which can in-principle be cleaved by esterase enzymes, and this makes PET an achievable target for biological recycling. PET can be bio-degraded to monomeric products such as bis(hydroxyethyl)terephthalic acid (BHET), mono(hydroxyethyl) terephthalic acid (MHET), terephthalic acid (TPA) and ethylene glycol (EG), which can be reused for the reproduction of recycled PET of high quality.<sup>10</sup> Thus, enzymatic degradation of PET offers a green and promising alternative with regeneration of monomers, thereby adding to the economy.

The century long exposure of PET to the ecosystems has provided a long time for the bacteria in the nature to evolve and utilize PET as a novel carbon source.<sup>10</sup> In 2016 for the first time, Yoshida *et al.* reported an enzyme, IsPETase from *Ideonella sakaiensis*, which can cleave PET at 30 °C.<sup>10</sup> IsPETase, belonging to hydrolase superfamily, shows high substrate specificity to PET, though it suffers from low reactivity and low thermal stability.<sup>11,12</sup> Since its discovery, a lot of research has been focusing on improving the efficiency and thermal stability by introducing mutations<sup>13–17</sup> and other strategies.<sup>18,19</sup> There are approximately 69 IsPETase like enzymes from phylogenetically different organisms, which can in principle degrade the ester linkage present in PET.<sup>14,20–22</sup> Studies to improve the

performance of these enzymes is indeed a valuable research area.<sup>23–25</sup> In the year 2022, a novel enzyme PHL7 was discovered by Zimmermann and co-workers, which shows promising activity for large scale degradation of PET.<sup>26,27</sup> In the same year, application of machine learning techniques are also used to design FAST-IsPETase,<sup>28</sup> which shows higher activity.<sup>28</sup>

Thus, unsurprisingly, the hydrolase family of enzymes from evolutionary diverse sources is greatly explored for the reactivity towards PET degradation. Among them, the bacterial thermophilic cutinase family have emerged as one of the suitable candidate for further research owing to its structural similarity and stability at high temperature between 60–84.7 °C,<sup>29,30</sup> which is much higher than the melting temperature ( $T_m$ ) of IsPETase (46.8 °C)<sup>14</sup> and above the glass transition temperature ( $T_g$  = 65–70 °C) of PET.<sup>31</sup> The earlier reports pointed out, that the most reactive bacterial cutinases towards PET are leaf compost<sup>32</sup> (LC-cutinase or LCC) and *TfCut2* from *Thermobifida fusca*.<sup>33</sup> The reactivity calculated by weight loss of low crystalline PET at 65–70 °C with LCC and G62A mutated *TfCut2* (ref. 15) after 24 h are 24% and 20% respectively.<sup>11</sup> Structural similarity of *TfCut2* (51%) with IsPETase is slightly more than that of LCC (49%), which makes *TfCut2* a valid target for our study.<sup>23</sup> Moreover, the amino acid residues involved in the cleavage of ester bond in *TfCut2* are the same as that of IsPETase.<sup>12</sup>

Muller *et al.* in 2005 first reported the PET degradation by *TfCut2* with a degradation rate of 2.5 nmol<sup>−1</sup> min<sup>−1</sup> cm<sup>−2</sup>.<sup>33</sup> Later in 2016, Barth *et al.* reported *TfCut2* could be inhibited by degradation products MHET and BHET, with MHET being the major inhibitor.<sup>15</sup> Though, degradation action of IsPETase is higher than that of WT *TfCut2* at their optimum temperatures on PET film,<sup>10</sup> a notable increase in activity was seen with the G62A mutation on *TfCut2*.<sup>15</sup> The mutant G62A decreased the binding constant by ~5.5 fold leading to relieved product inhibition by MHET than in WT *TfCut2*. In 2019, Furukawa and co-workers added another mutation F209A to the single mutant resulting in G62A/F209A double mutant (DM) *TfCut2* with a PET degradation rate of 15.0 nmol<sup>−1</sup> min<sup>−1</sup> cm<sup>−2</sup>.<sup>11</sup> Interestingly, in 2018 Austin *et al.* reported a double mutant W130H/S209F IsPETase, which mimics the active site of *TfCut2* cutinase showing a higher PET degradation rate.<sup>13</sup> However, the enzymatic PET degradation process is yet to be used in a large scale.<sup>34,35</sup> Therefore, to improve the bio-degradability of PET, it is very important to identify the important amino acid residues present in the enzyme responsible for the interaction with PET and at the same time classify the nature of interaction these amino acid residues exhibits. This process would help engineering of PET degrading enzymes with higher reactivity.

In general, it is observed that mutations can increase the activity of all these enzymes. However, a systematic approach in predicting appropriate mutations to achieve optimum PET degradation is elusive. Thus, our study aims to correlate the increased PET degradation activity of DM *TfCut2* with the structure-based role of the mutation, which not only is instrumental for understanding the catalytic mechanism but it will also offer avenues for the applications of genetic engineering strategies to improve the efficiency of enzymes. In doing this, the major challenge is the complexity in characterizing all plausible

approaching pathways that can lead to different PET binding conformations on the target protein. In order to address this, the detailed structural information as well as different types of interactions on different PET binding states at the molecular level was analysed based on Molecular Dynamics Simulations and Quantum Mechanical calculations to gain a deep understanding and rational control of PET binding. We have chosen the *TfCut2* (WT) and its double mutated (DM) variant G62A/F209A and a tetrameric PET, 2-hydroxyethyl-(monohydroxyethyl terephthalic acid)<sub>4</sub> (2-HE(MHET)<sub>4</sub>) for our theoretical study.

## Computational details

### Structure preparation of proteins and PET

The PDB structure 4CG1 (resolution 1.40 Å) was used as starting structure for WT *TfCut2*.<sup>36</sup> The missing residue, Asp246 was added using SWISS-PROT.<sup>37</sup> Hydrogens were added using AMBER20<sup>38,39</sup> leap program corresponding to the protonation states predicted by H++<sup>40</sup> at pH 7. The protein structure thus obtained was minimized for 10 000 steps using the steepest descend-algorithm<sup>41</sup> using the CUDA version of pmemd program in AMBER20.<sup>38</sup> G62A/F209A *TfCut2* (ref. 11) structure was prepared from the above WT *TfCut2* structure by introducing mutations *via* PyMOL.<sup>42</sup> 2-Hydroxyethyl-(monohydroxyethyl terephthalic acid)<sub>4</sub> or 2-HE(MHET)<sub>4</sub> was taken as a representative of PET polymer.<sup>14</sup> Note that, earlier reports indicate that the tetrameric PET is long enough to establish contact with the entire binding cleft of *TfCut2*.<sup>14</sup> The tetrameric PET structure is minimized using the B3LYP<sup>43</sup> functional and 6-31+g(d)<sup>44,45</sup> basis set using Gaussian 09 program package.<sup>46</sup> The molecular electrostatic surface potential (MESP) of the protein was calculated using PDB2PQR<sup>47,48</sup> online server followed by continuum electrostatics calculations employed in the Poisson–Boltzmann solver (ABPS).<sup>49</sup>

### Molecular docking

The minimized tetrameric PET and protein structure was used for performing 11 sets of docking on each protein *viz.* WT *TfCut2* and G62A/F209A *TfCut2* with PET tetramer using Auto-dock Vina.<sup>50</sup> The 99 PET conformers thus generated were classified using a distance cutoff of 5 Å between any ester carbonyl carbon-atom of PET to the hydroxy-oxygen atom of the catalytic serine. These structures were further grouped using a PET RMSD cut-off of 2 Å. This procedure resulted in 19 and 16 different poses of PET with WT and DM *TfCut2* respectively, which were subsequently used for Molecular Dynamics Simulations to investigate the conformational landscape.

### Parametrization of PET and molecular dynamics simulations

PET was parametrized using the antechamber<sup>51</sup> module of AMBER20<sup>38</sup> using AM1-BCC<sup>52</sup> charge model and the Generalized AMBER Force Field (GAFF).<sup>53</sup> The protein part was treated with the ff14SB<sup>54</sup> forcefield. Proteins with docked tetrameric PET was placed in 0.15 M NaCl with TIP3P<sup>55,56</sup> water in a truncated octahedron box. Non bonded interactions were restricted to 12 Å cut-off and long range electrostatic interactions were treated



using the particle mesh Ewald method.<sup>57</sup> Solvated protein-PET system was relaxed by minimization of 10 000 steps using the steepest descend-algorithm.<sup>58</sup> The system was gradually heated in 100 K increments from 0 K to 300 K with positional restraints on the protein and tetrameric PET system for 120 ps. Positional restraint was then slowly reduced from 12 kcal mol<sup>-1</sup> Å<sup>-2</sup> to zero for the protein, but by retaining a 0.5 kcal mol<sup>-1</sup> Å<sup>-2</sup> restraint on PET, which was then released followed by a 200 ns production run on each of the structures obtained from docking study. The 4 trajectories where PET moved out of the binding site were not considered further, while the rest was run for 1 μs simulation. This resulted in 15 and 12 simulations each of one μs duration for WT and DM *TfCut2*, respectively. Also, a total of 1 μs MD simulation on WT and DM proteins without PET were performed.

All MD simulations were performed at a constant pressure of 1 bar in the *NPT*<sup>59</sup> ensemble. Hydrogen-mass repartition<sup>60</sup> along with SHAKE<sup>61</sup> algorithm has been applied on bonds involving hydrogen atoms. VMD,<sup>62</sup> CPPTRAJ<sup>63</sup> and the Qt version of xmgrace<sup>64</sup> were used for trajectory analysis. The simulations were clustered into different groups by the average-linkage hierarchical clustering algorithm<sup>65</sup> in AMBER20. Clustering using this algorithm is reported to be a reliable approach for analysing the MD trajectories.<sup>65</sup> The trajectories obtained after clustering were subjected to binding energy calculations using the Molecular Mechanics-Poisson Boltzmann Surface Area<sup>66</sup> (MM-PBSA) method. Though this binding energy calculation does not include the entropic contribution to ligand-binding affinity, it is still reported to give a good correlation with the experimental values.<sup>67</sup> Normal-mode analysis was carried out on extended and folded conformers of PET with WT and DM protein systems using the nabnmode module of AMBER to estimate the conformational entropy contributions to the binding free energy using Kongsted method (Fig. S11†).<sup>68</sup> This follows the same trend as the MM-PBSA energies, indicating an steady entropy contribution for all the conformers. Further to highlight the most important residues involved in the ligand recognition, MM-PBSA per residue energy decomposition analysis was also carried out.

## Quantitative estimation of PET binding energy

The lower order symmetry adapted-perturbation theory calculations, SAPT0<sup>69,70</sup> which comes with a good error cancellation with jun-cc-pvDZ<sup>71</sup> basis was employed with density fitting techniques and core electron freezing<sup>70</sup> using the quantum chemistry package PSI4.<sup>72</sup> The total interaction energy in SAPT is a sum of energy terms arising from electrostatic, exchange, induction and dispersion effects.<sup>70</sup> Further, PET binding energy was calculated including dispersion<sup>73</sup> corrections at the B3LYP-D3/6-31+g(d) level of theory by correcting basis set super position error using Gaussian 09 program package.<sup>46</sup>

## Results and discussion

The amino acid residues involved directly in the ester bond cleavage of PET are conserved in wild type (WT) and double mutated (DM) cutinase, yet the catalytic activity differs significantly. Hence, the catalytic activity of these enzyme is hugely dependent upon the molecular recognition of the substrate to the PET binding site through multiple weak non-covalent interactions. Concomitantly, the extent of these weak interactions depends upon the orientation of the amino-acid side chain residues and the binding poses of the substrate. A deeper understanding of the complementary molecular reactivity and molecular recognition of PET by cutinase can be obtained by the detailed analysis of the plausible PET binding poses on the protein surface.

### PET binding poses on WT and DM *TfCut2*

In order to gain a preliminary understanding, we have extensively explored 99 possible binding poses of tetrameric PET the with the PET binding cleft of each of WT and DM *TfCut2* by molecular docking using AutoDock Vina.<sup>42</sup> The DM *TfCut2* has an average binding affinity of -6.5 kcal mol<sup>-1</sup> (range: -5.0 to -7.5 kcal mol<sup>-1</sup>) which is a little higher than the average binding affinity of WT *TfCut2*, -5.5 kcal mol<sup>-1</sup> (range: -4.2 to -7.2 kcal mol<sup>-1</sup>). 46 conformations show a docking score higher than the average binding affinity in WT *TfCut2*, while 72 conformations of tetrameric PET in DM *TfCut2* have a docking score higher than the average. However, all the binding poses with higher docking score are not identical, which warrants

more thorough analysis of the different binding poses to enable structural basis for enhanced degradation due to mutation.

The observed PET binding poses from docking can be broadly classified into three categories, (i) extended, where the entire tetrameric PET maintains contact with the entire binding cleft (ii) semi-extended where the tetrameric PET does not bind throughout the entire region of binding cleft and (iii) folded, where the tetrameric PET forms a loop like structure, binding only to a very small region (Fig. 1). Austin *et al.*<sup>13</sup> and Joo *et al.*<sup>14</sup> in two separate works had reported that tetrameric PET adopting an extended conformation in IsPETase shows higher docking score as well as higher reactivity. Likewise, we have identified the extended PET conformers among the docked structures for both WT and DM *TfCut2*. Only 15 docked poses exhibit extended conformation in WT *TfCut2* (Fig. 2a), while as much as 51 docked poses exhibit extended conformation in DM *TfCut2* (Fig. 2b). Thus, the binding site cleft of DM *TfCut2* seems more suitable to extended PET conformations, whereas folded PET conformations are more common for WT *TfCut2*. A comprehensive analysis of the docked conformations of PET indicates that PET binds to three-fourths of the active site (up to F209) in a similar fashion in both WT and DM *TfCut2*. The visual inspection revealed that DM *TfCut2* uses an unprecedented terminal region of the protein for binding PET in the extended conformation as compared to WT *TfCut2* (Fig. 2). Earlier binding studies did not indicate PET binding to such residues.<sup>13,14,36,74–77</sup> At this point we might reason that, the mutation of the aromatic Phe209 (F209) in WT to hydrophobic Ala209 (A209) in DM cutinase might have affected the conformation of PET binding on the surface of cutinase. However, further analysis is required to elucidate this striking difference in the mode of PET binding upon mutation.

From theoretical mechanistic studies on the enzymatic PET hydrolysis,<sup>78–82</sup> it was proposed that the hydroxyl group of Ser130 of the catalytic triad initiates the attack to the carbonyl carbon of the ester bond, followed by the stabilization of the negative charge by the two back bone nitrogen atoms of Tyr60 and Met131 of the oxyanion hole.<sup>83</sup> Thus, in order to identify the best binding poses of PET with WT and DM *TfCut2* in terms of catalytic activity, it is very important to analyse the proximity of

the carbonyl carbon-atom of PET to Ser130 that lie in the subsite S1. Thus, a distance cut off of 5 Å is used to identify 62 and 65 PET poses respectively for WT and DM *TfCut2*. These structures were further grouped together by a PET RMSD cut-off of 2 Å, and one representative pose with the highest docking score was selected from each group. This resulted in shortlisting of 19 and 16 PET complex of WT *TfCut2* and DM *TfCut2* respectively (Fig. S2 and S3†), which were further subjected to detailed analysis to identify what might be responsible for PET binding to novel sub-site in DM cutinase.

### Analysis of structure and electrostatic potential of WT & DM *TfCut2*

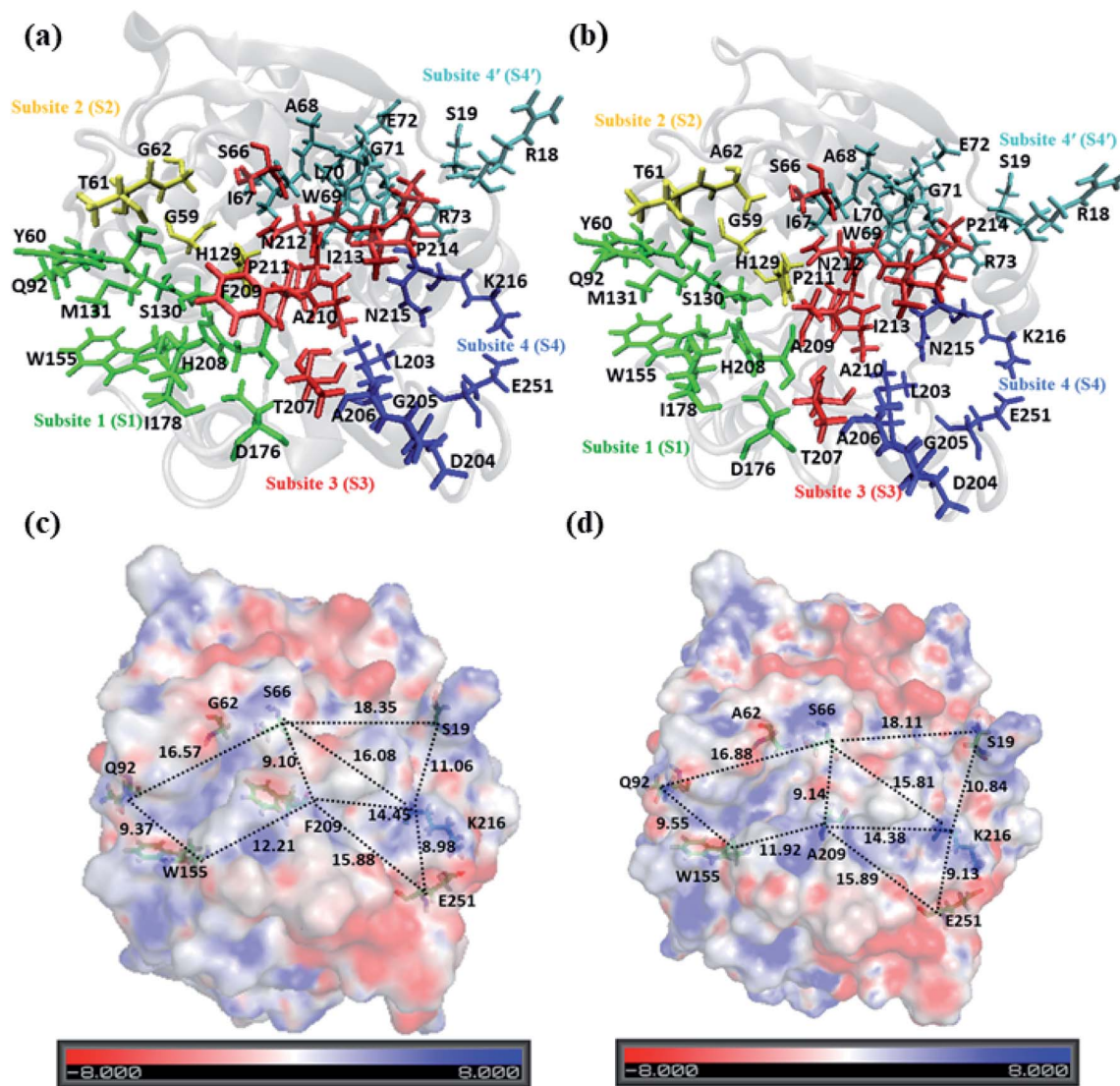


Fig. 3 Cartoon representation of (a) WT *TfCut2* and (b) DM *TfCut2* with amino acid residues in subsites S1, S2, S3, S4 and S4' shown in green, yellow, red, blue and cyan licorice representations respectively. Plot of molecular electrostatic potential (MESP) for (c) WT *TfCut2* and (d) DM *TfCut2* with potential over the range  $-8.0$  to  $+8.0$  kT/e.

A closer look at the entire PET binding cleft of cutinase reveals that it constitutes of 36 amino acid residues (Fig. 3). These amino acid residues can be divided into two categories, the ones that are directly involved in the catalytic cleavage of the ester bonds or catalytic residues, the others that are involved mainly in the recognition and binding of PET on the protein surface or anchor residues. One can classify the entire cleft into four major subsites *viz.* S1, S2, S3 and S4, where each subsite can roughly accommodate a monomeric PET unit. A similar description of the entire binding cleft was also provided for PET degrading enzyme IsPETase.<sup>14,77</sup> However, our docking studies have identified an unprecedented binding subsite, named as S4' that seems an alternative to S4. Note that, the binding of PET into S4' was not previously reported. Also, the presence of Arg18 at the extreme end of S4' have close resemblance with the binding sub-site S4 of IsPETase, where Arg251 marks the end of the binding cleft.<sup>14</sup> For easy identification purpose, the amino acid residues in each subsite are colour coded as green (S1), yellow (S2), red (S3), blue (S4) and cyan (S4') respectively for both WT and DM *TfCut2* (Fig. 3a and b). Fig. 3c and d indicates that, the conventional binding cleft constituted by subsites S1, S2, S3 and S4 has a narrow and inverted V-shape (Q92, W155, F209/A209, E251, K216, S66), while the binding cleft constituted by subsites S1, S2, S3 and S4' appears to be wider and linear (Q92, W155, F209/A209, K216, S19, S66). Also, the distance between the C-alpha atoms of the terminal residues shows that the mutation does not alter the overall size and shape of the cavity.

The plot of the molecular electrostatic potential (MESP) on the van der Waals surface clearly indicates that the S1, S2 and S3 subsites are mostly neutral with slight negative region in S1 and S3 due to the presence of aromatic Trp155 (W155), Tyr60 (Y60) and Phe209 (F209) residues while the S4 subsite is mainly polar with both electrophilic and nucleophilic regions near Lys216 (K216) and Glu251 (E251) respectively (Fig. 3c). Similar to S4, the alternate subsite S4' also contains both nucleophilic (Trp69 and Glu72) and electrophilic (Arg73 and Arg18) residues, indicating similarity in the molecular electrostatic potential. The mutations of Gly62 by Ala62 in S2 and Phe209 by Ala209 in S3 did not change the overall MESP. However, local decrease in the electron density near the Phe209 in WT *TfCut2* is observed after the mutation (Fig. 3d).

#### Molecular-dynamics simulations on WT and DM (G62A/F209A) *TfCut2* with and without PET

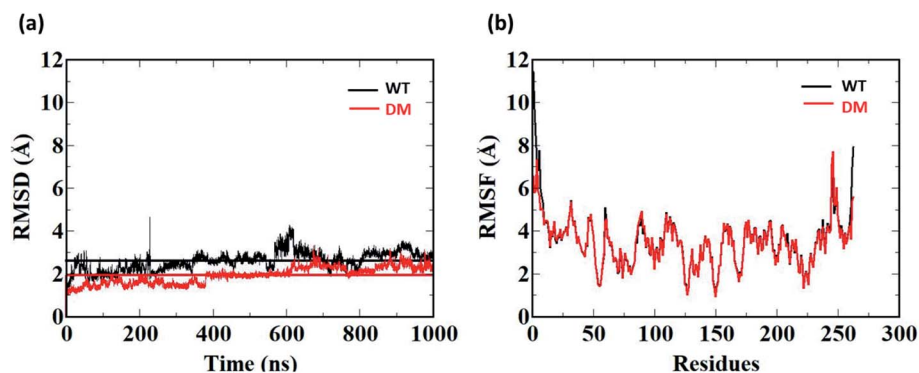


Fig. 4 Root mean square deviations (RMSD) and root mean square fluctuation (RMSF) in Å of the 1  $\mu$ s Molecular Dynamics Simulation of WT *TfCut2* (black) and DM G62A/F209A *TfCut2* (red). The average RMSD is indicated by a line parallel to the x-axis in corresponding axis.

1  $\mu$ s Molecular Dynamics simulations was carried out on WT and DM *TfCut2* with and without PET to identify the amino acid residues and their corresponding nature of interactions responsible for PET recognition. The average RMSD value of the WT and DM *TfCut2* without the tetrameric PET is 2.60 Å and 1.93 Å respectively (Fig. 5a), depicting overall stability of the proteins. The RMSD of the average structures generated after 1  $\mu$ s Molecular Dynamics simulations on WT and DM *TfCut2* without PET, showed an average RMSD of 1.33 Å of the DM *TfCut2* with respect to the WT variant. The RMSF analyses indicates higher fluctuation of the N-terminal and C-terminal residues (Fig. 4b and S1†). The low RMSD of the average structures (0.83 Å) by excluding the N-terminal and C-terminal

residues highlights the importance of the local conformational changes for PET recognition.

To explore the binding interaction of PET with the side-chain in WT and DM *TfCut2*, 1  $\mu$ s MD simulation was run on each of the selected 15 and 12 PET conformers for the WT and DM *TfCut2* respectively. The analysis of the RMSD (Fig. S4 and S5<sup>†</sup>) shows that though the RMSD of the protein–PET complexes is significantly higher, the RMSD of protein alone in the protein–PET complex is similar to that of the proteins. Thus, the significant change in the RMSD of the protein–PET complex is mainly contributed from the different conformations adopted by PET in the PET binding cleft. Looking at the trajectories, conversion between the folded and extended conformers of PET is widely observed, validating the possible binding of both the conformers in the binding cleft. In addition, the RMSF plot of the cavity residues with and without PET indicates that the subsites S1 and S3 undergo greater extent of conformational changes in WT *TfCut2*, while subsite S1, S4/S4' undergo major changes in DM *TfCut2* for PET binding (Fig. S6<sup>†</sup>).

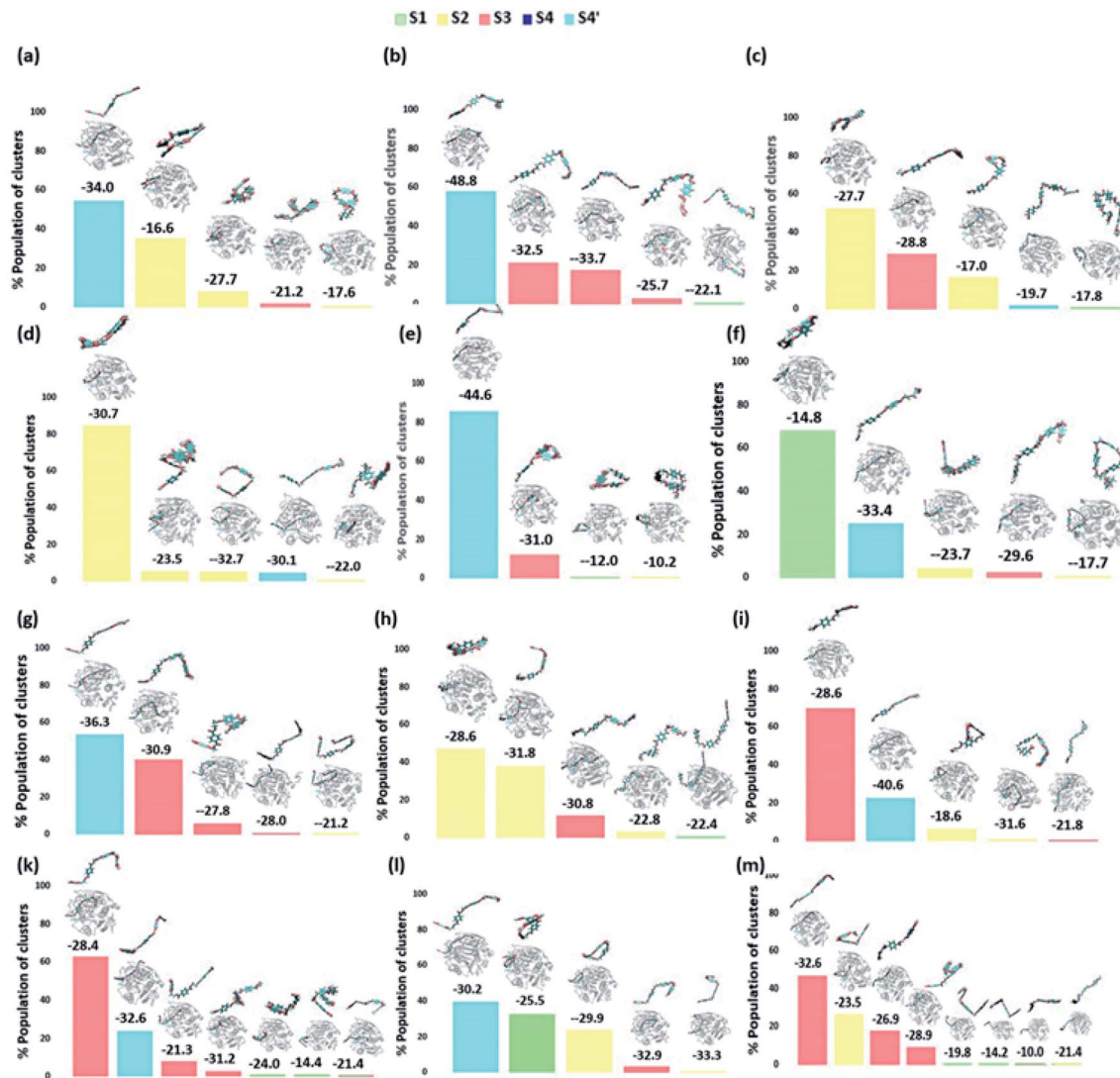


Fig. 6 The output of clustering on 12 different DM *TfCut2*-PET systems with the population percent of each cluster shown in Y axis. The average structure of each cluster along with its binding energy ( $\text{kcal mol}^{-1}$ ) obtained via MM-PBSA calculations is shown above the bar corresponding to each cluster. A zoomed image of PET is shown on top of each average structure.

We have further used hierarchical average-linkage clustering implemented in AMBER20 to identify the major conformational isomers of PET from the MD simulation trajectories of the PET bound WT and DM *TfCut2*. Clustering of all the trajectories for WT and DM *TfCut2* produced 78 and 67 clusters respectively (Fig. 5 and 6). The clustering analysis of WT *TfCut2* clearly indicates that, majority of the trajectories yield a single preferred conformation, which is corroborated well with the minimal fluctuation observed in the RMSD and RMSF (Fig. S4–S6<sup>†</sup>). The WT *TfCut2* shows a clear preference for PET conformers that are interacting with the Phe209 of the S3 subsite leading to either a semi-extended or a folded conformation. There are only a few instances where PET attain a fully extended conformation by binding throughout all the four subsites S1–S4/S1–S4'. The binding affinity of all the PET conformers in each cluster was calculated using MM-PBSA analysis, which ranges from  $-15.2$  kcal mol<sup>-1</sup> to  $-38.1$  kcal mol<sup>-1</sup> (Fig. 5). Among the prominent clusters, the higher binding energy is mostly observed for the semi-extended PET conformers, which indicates the prominent role of Phe209.

On the contrary, the clustering analysis on the trajectories of DM *TfCut2* reveals conformational flexibility of PET in the

binding cavity leading to more than one prominent clusters. This corroborates with the higher RMSD and RMSF as compared to WT cutinase (Fig. 6). Note that, majority of them indicates binding to the hitherto unidentified subsite S4' leading to fully-extended conformations more often than WT *TfCut2*. Also, the binding energy of PET in DM *TfCut2* ranges from  $-10.2$  to  $-48.8$  kcal mol<sup>-1</sup> and the binding energies for the fully extended PET conformers binding to S1–S4' subsites are noticeably higher. Therefore, the higher PET affinity of DM *TfCut2* than WT variant can possibly result from binding to the novel subsite S4', which also leads to extended PET conformations. Note that, the extended PET conformations in the binding cleft has been linked with higher activity of *IsPE-Tase*.<sup>13,14</sup> Thus, extended PET conformations with relatively higher binding energy might lead to higher activity in *TfCut2* as well.

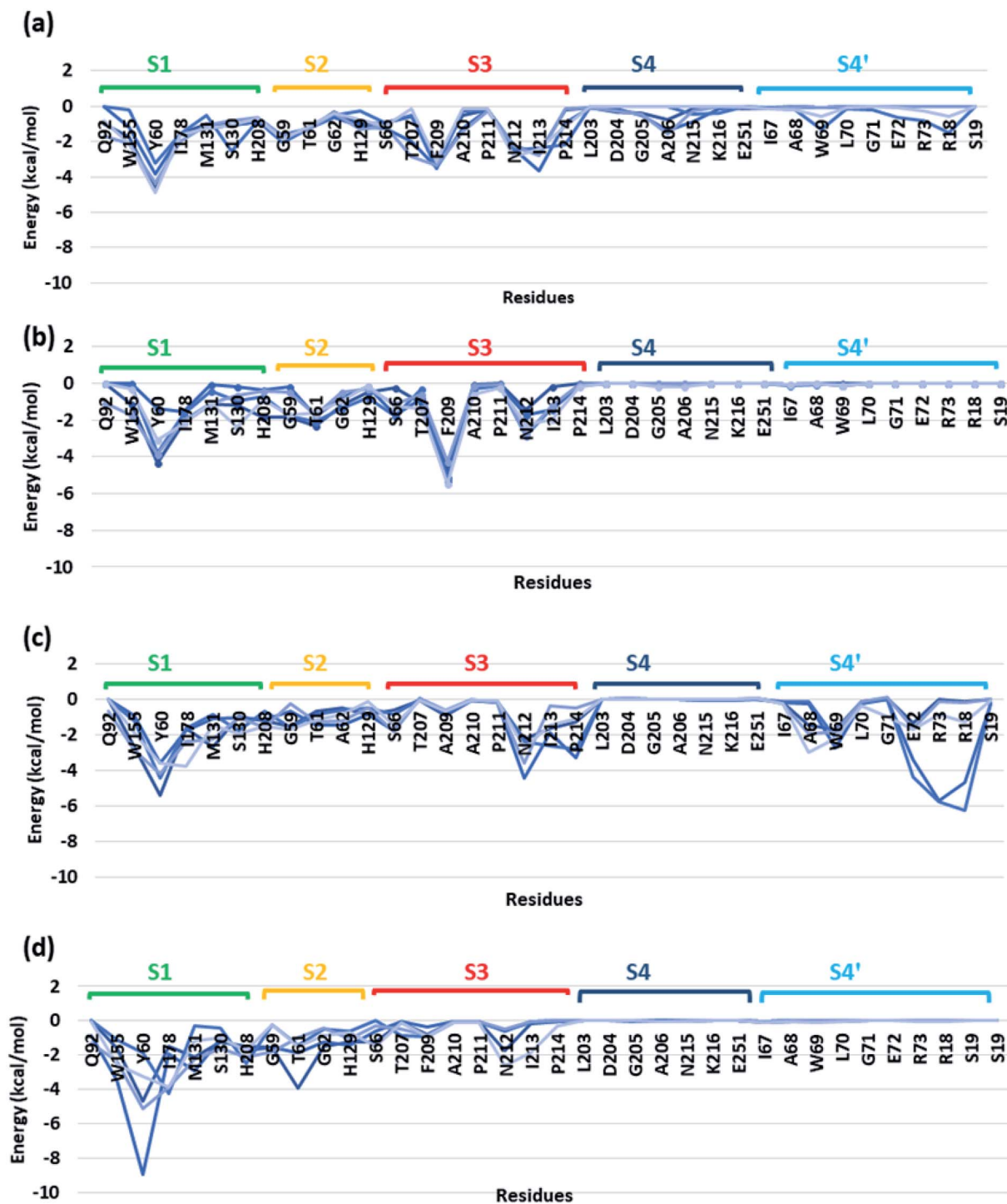


Fig. 7 Pairwise energy contribution of residues with PET for five extended and folded clusters of (a) WT *TfCut2* extended PET conformer (b) WT *TfCut2* folded PET conformer (c) DM *TfCut2* extended PET conformer and (d) DM *TfCut2* folded PET conformer calculated using MM-PBSA method.

In order to identify the residues that might play important role in energetically favouring extended PET conformations over the folded ones, we have selected the trajectories corresponding to extended and folded conformations having the five highest and five lowest binding energies in both WT and DM *TfCut2*. The average structures of these 20 conformers are given in Fig. S7 and S8<sup>†</sup>. Note that, fully-extended PET conformations are only observed for DM *TfCut2*, while the WT *TfCut2* exhibits semi-extended conformations. The Fig. S9, S10 and S12<sup>†</sup> show the contact plot analysis, MM-PBSA per-residue binding energy and comparison of average per residue binding energy with the average close contact respectively calculated using MM-PBSA method for each subsite on the extended and folded PET for WT and DM *TfCut2*. The pair-wise binding energy for PET with all the residues of the entire PET binding cleft of WT and DM *TfCut2* (S1, S2, S3, S4 and S4') was plotted in Fig. 7. We can clearly see different interaction energy pattern for the WT and DM *TfCut2* as well as for the extended and folded PET. In general, the residues with highest number of close contacts have higher interaction energy with PET. We have also performed zero order Symmetry Adapted Perturbation Theory (SAPT0) analysis to get a quantitative picture of different energy components contributing to the total energy.

The S1 residues Ser130 from the catalytic triad and Tyr60, Met131 from oxyanion hole that are essential for the ester bond

cleavage of PET as well as the anchor residues such as hydrophobic Ile178 and aromatic Trp155 that are essential for PET binding exhibit more close contact and higher energy contribution irrespective of the conformational change and mutation (Fig. S9, S10 and Movie S1†). Thus, the residues in S1 can be considered as the most important for the PET recognition and cleavage by cutinases. Hence, any mutation at S1 might compromise the recognition and degradation of PET. Indeed studies on *IsPETase*, which also contain the same residues, shows decline in activity upon mutation of S1 residues.<sup>14,84</sup>

Tyr60 of the oxyanion hole is a non-polar aromatic residue with a PhOH functional group. Three main interactions *viz.*, displaced  $\pi$ -stacking ( $\text{PET-Ph} \cdots \text{Ph}_{\text{Y60}}$ ), T-stacking ( $\text{PET-C-H} \cdots \text{Ph}_{\text{Y60}}$  and  $\text{Y}_{60}\text{C-H} \cdots \text{Ph}_{\text{PET}}$ ) are mainly observed between Tyr60 and PET along with hydrogen bonding between amide hydrogen of Tyr60 and carbonyl oxygen of PET ( $\text{PET-O} \cdots \text{H-N}_{\text{Y60}}$ ) ( $-10.7$ ,  $-7.8$  and  $-7.0 \text{ kcal mol}^{-1}$  in Fig. 8a-c and Movie S1†).

Note that, the hydroxyl group of Tyr60 does not interact with non-polar functional groups in PET. The other two residues, Met131 and Ser130, responsible for the ester bond cleavage show lesser number of interactions and less energy contribution as compared to Tyr60. The non-polar Met131 is involved in weak  $\text{M}_{131}\text{C-H} \cdots \pi_{\text{PET}}$ , hydrophobic  $\text{M}_{131}\text{C-H} \cdots \text{H-C}_{\text{PET}}$  and  $\text{PET-O} \cdots \text{H-N}_{\text{M}_{131}}$  hydrogen bonding ( $-4.3 \text{ kcal mol}^{-1}$ , Fig. 8d) and the polar Ser130 show occasional hydrogen bonding interaction  $\text{S}_{130}\text{O-H} \cdots \text{O}=\text{C}_{\text{PET}}$  with the carbonyl group of the PET ( $-6.2 \text{ kcal mol}^{-1}$ , Fig. 8e) in the neutral state, which resembles the state prior to proton abstraction by His208 in the catalytic cycle.<sup>78,80</sup> The aromatic residue Trp155, which is responsible for anchoring the phenyl ring of PET to S1, shows  $\text{PET-C-H} \cdots \pi_{\text{W}_{155}}$  ( $-8.1 \text{ kcal mol}^{-1}$ , Fig. 8f) interaction and weak T-stacking interaction with PET ( $-5.0 \text{ kcal mol}^{-1}$ , Fig. 8g). The hydrophobic residue Ile178 shows mainly weak  $\text{I}_{178}\text{C-H} \cdots \pi_{\text{PET}}$  interaction with one or both phenyl rings of PET

( $-6.5 \text{ kcal mol}^{-1}$ , Fig. 8h). The interaction energy of Tyr60, Ile178 and Trp155 are found to be highest in the folded PET conformer with double mutated *TfCut2*, explaining the overall higher interaction energy for the folded PET conformer in DM *TfCut2* as compared to WT *TfCut2*.

Other than Ser130, the major contribution to the total interaction energy with PET comes from dispersion component indicating the importance of hydrophobic interaction (Fig. S13 and S14<sup>†</sup>). However, the polar Ser130 has electrostatic component as major contributor to the total interaction energy (Fig. S13 and S14<sup>†</sup>). Note that, even though the energy

corresponding to the individual interaction energy is very less, a significant contribution arises from the cooperative stabilizing effect of multiple non-covalent interactions leading to preferential PET recognition.

Weak hydrophobic C-H...H-C interactions of PET are mainly observed with Gly59 and Gly62 ( $-4.9$  and  $-1.1$  kcal mol $^{-1}$ , Fig. 9a and b) from S2. The mutation of Gly62 with Ala62 ( $-1.5$  kcal mol $^{-1}$ , Fig. 9c) does not affect the interaction energy, hence might not play important role in PET binding and cleavage. Indeed, the major role of G62A mutation was reported to assist in release of product.<sup>74</sup> Polar hydroxyl group of Thr61 shows hydrogen bonding  $\text{PETC=O}\cdots\text{H-O}_{\text{T61}}$ ,  $\text{PETC-O}\cdots\text{H-O}_{\text{T61}}$  interactions and the methyl group is involved in  $\text{PETC-H}\cdots\text{H-C}_{\text{T61}}$  and  $\text{T61C-H}\cdots\pi_{\text{PET}}$  interactions ( $-4.3$  kcal mol $^{-1}$ , Fig. 9d). Occasional close contact with the S2

residue His129 is observed in WT and DM *TfCut2*. Unlike the aromatic residue Phe209 in S3, His129 does not participate in stronger  $\pi$ - $\pi$  interaction due to the unfavourable conformation perpendicular to the phenyl ring of PET, instead shows weak  $\text{H}_{129}\text{C-H}\cdots\text{H-C}_{\text{PET}}$  and  $\text{H}_{129}\text{C=O}\cdots\text{H-C}_{\text{PET}}$  interactions ( $-4.2$  kcal mol $^{-1}$ , Fig. 9e). Note that, mutation of Trp159 in WT *IsPETase* with His159 increases the activity significantly.<sup>13</sup> Thus, S2 residues in general show less contact and hence lower interaction energy with PET as compared to S1, irrespective of the conformational change of PET as well as G62A mutation of *TfCut2*. Also, the presence of non-polar residues in S2 is corroborated with the dispersion interaction being the major energy component (Fig. S13 and S14 $^\dagger$ ).

The next subsite that shows significant close contact with PET is S3, where the aromatic residue Phe209 in WT *TfCut2*

exhibit greater contact with both the semi-extended and folded PET conformers through displaced  $\pi$  and T-stacking interactions with the phenyl ring of PET ( $-8.5$  kcal mol $^{-1}$ , Fig. 10a and Movie S2 $^\dagger$ ). When F209 is mutated to aliphatic Ala209, the  $\pi$ - $\pi$  interactions are no longer present rather weak hydrophobic  $\text{C-H}\cdots\text{H-C}$  and hydrogen bonding  $\text{PETC=O}\cdots\text{H-C}_{\text{A209}}$  interactions are observed, which is also reflected in the significant lowering of the interaction energy upon mutation ( $-1.9$  kcal mol $^{-1}$ , Fig. 10b and Movie S3 $^\dagger$ ). In addition, semi-extended PET in WT *TfCut2* exhibit major interaction with polar Asn212 and hydrophobic Ile213 from S3, which are not found in folded PET conformers (Movie S4 $^\dagger$ ). Polar Asn212 shows hydrogen bonding  $\text{N}_{212}\text{C=O}\cdots\text{H-C}_{\text{PET}}$ ,  $\text{PETC=O}\cdots\text{H-N}_{212}$  as well as  $\text{N}_{212}\text{C-H}\cdots\pi_{\text{PET}}$  and  $\text{PETC-H}\cdots\text{H-N}_{212}$  interactions ( $-6.8$  kcal mol $^{-1}$ , Fig. 10c), while nonpolar Ile213 is involved in  $\text{I}_{213}\text{C-H}\cdots\pi_{\text{PET}}$  and  $\text{I}_{213}\text{C-H}\cdots\text{H-C}_{\text{PET}}$  interactions ( $-6.8$  kcal mol $^{-1}$ , Fig. 10d). However, mutation of aromatic residue Phe209 to hydrophobic Ala209 had reduced the close contact of both extended and folded PET with S3 of DM *TfCut2*, while maintaining the close contact with Asn212 and Ile213 in the extended form.

In addition, Pro214, which is situated at the end of S3 shows significantly high close contact and interaction energy contribution due to  $\text{P}_{214}\text{C-H}\cdots\pi_{\text{PET}}$  interaction, indicating the preference of the extended PET in DM *TfCut2* ( $-8.2$  kcal mol $^{-1}$ , Fig. 10e) as compared to semi-extended PET in WT *TfCut2*. Ser66 on the other hand, though a polar residue, mainly shows weak hydrophobic interactions  $\text{S}_{66}\text{C-H}\cdots\text{H-C}_{\text{PET}}$  in both WT

and DM cutinase ( $-4.2$  kcal mol $^{-1}$ , Fig. 10f). Likewise, the contribution from the dispersion energy is major in all residues other than polar Asn212, where electrostatic component is higher (Fig. S13 and S14 $^\dagger$ ).

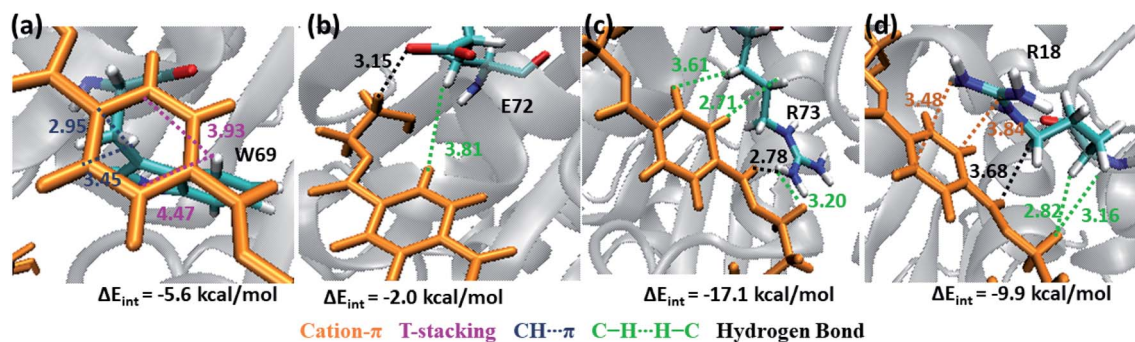


Fig. 11 Snapshots showing major interactions in subsite S4' (color code same as above). Cation- $\pi$  interactions which are unique in S4' are shown in orange color. The single letter code indicating the amino acids are Trp (W), Glu (E) and Arg (R).

Note that, no residues from S4 in both WT and DM *TfCut2* show any close contact with either semi-extended, extended or folded PET conformers. Accordingly, the energy contribution of S4 residues is minimum (Fig. S12 $^\dagger$ ). The striking difference in terms of close contact with the extended PET in DM *TfCut2* as compared to semi-extended PET in WT *TfCut2* is observed for the novel S4' subsite residues. The MESP analysis (Fig. 3c and d) revealed that the subsite S4' contains both polar and non-polar residues. The energy contribution from nonpolar aliphatic residues Ile67, Ala68, Leu70 and Gly71, as well as polar Ser19 is not significant. However, the aromatic residue Trp69 shows T-stacking and  $\text{W}_{69}\text{C-H}\cdots\pi_{\text{PET}}$  interactions with the phenyl ring of PET ( $-5.6$  kcal mol $^{-1}$ , Fig. 11a). The carboxylic group of Glu72 interacts with PET via  $\text{E}_{72}\text{C=O}\cdots\text{H-C}_{\text{PET}}$  and hydrophobic  $\text{C-H}\cdots\text{H-C}$  interactions ( $-2.0$  kcal mol $^{-1}$ , Fig. 11b). Arg73 shows strong hydrogen bonding interaction with the hydrogen of guanidino group and carboxyl oxygen of PET ( $\text{PETC=O}\cdots\text{H-N}_{\text{R73}}$ ) and  $\text{PETC-H}\cdots\text{H-N}_{\text{R73}}$  interactions  $-17.1$  kcal mol $^{-1}$ , Fig. 11c). The terminal Arg18 having major contribution shows cation- $\pi$  interaction with the phenyl ring of PET in addition to the  $\text{PETC=O}\cdots\text{H-C}$  hydrogen bonding ( $-9.9$  kcal mol $^{-1}$ , Fig. 11d and Movie S5 $^\dagger$ ). The SAPT0 breakdown of the total interaction energy indicates that the major

contribution comes from the dispersion components except for polar Arg residues, which have high electrostatic component. The significantly higher close contact and interaction energy with polar S4' residues like Arg18, Trp69, Arg73 and Glu72 indicates that, the S4' plays a vital role in attaining favourable fully extended PET conformation in DM *TfCut2*, which might be prevented by the  $\pi$ - $\pi$  interaction of the aromatic Phe209 in S3 of WT *TfCut2*.

From these results, one may infer that S1 is important for both binding and cleavage of PET and mutation in S1 might cause reduction in the PET degradation activity either due to poor binding or poor cleavage. In accordance with that, S1

shows very high binding energy irrespective of the conformational change as well as mutation (Fig. S14†). The next important subsite is S3, which plays very important role in anchoring the aromatic phenyl ring of PET with Phe209 by  $\pi$ - $\pi$  interaction in WT *TfCut2*. However, note that, this interaction also restricts PET to attain a favourable extended conformation as well as might delay the sequential approach of the ester bonds close to the catalytic residues situated in S1 (Scheme 1). The loss of  $\pi$ - $\pi$  interaction in DM cutinase due to F209A mutation is compensated by cation- $\pi$ , hydrogen bonding and hydrophobic interactions from the Arg18, Trp69, Arg73 and Glu72 residues in S4', which not only gives higher binding energy but also assist the

fully extended PET conformation. A combination of these factors may in turn facilitate higher degree of PET degradation by DM *TfCut2*. Therefore, an optimum balance between the two opposing effect *viz.* the intrinsic PET affinity to the enzyme surface and PET binding to the active site seems to control the extent of degradation. While our manuscript was under review, Kari and Westh have showed that Sabatier principle might be helpful in rationalizing the optimum enzymatic PET degradation processes,<sup>25</sup> which supports our analysis.

## Conclusions

In this study, we have explored the different conformational states and binding affinity of the tetrameric PET with the amino acid residues from the PET binding cleft of wild type and double mutated cutinase using molecular dynamics simulations and quantum mechanical approaches. We demonstrate that mutations of anchor residue phenyl alanine to alanine at the PET binding cleft of cutinase alters the conformation of PET on the binding surface of the mutated cutinase demonstrating structural adaptability of ligand on the protein surface. This unveiled a distal yet novel binding subsite, which alters the nature of dispersive interaction for PET recognition and binding. The phenyl alanine engages in  $\pi$ - $\pi$  interaction with the phenyl ring of PET ( $-8.5$  kcal mol<sup>-1</sup>), which at one side helps in PET recognition, but at the other side restricts PET to attain fully extended conformations over the entire binding cleft. The loss of  $\pi$ - $\pi$  interaction due to mutation of phenyl alanine to alanine is not only compensated by the favourable cation- $\pi$  and hydrophobic interactions from the arginine residues ( $-17.1$  kcal mol<sup>-1</sup>) found in the newly discovered subsite, but also favours the fully extended PET conformation. Thus, a perfect balance between the PET recognition and binding by the anchor residues and attainment of suitable conformation for the cleavage would likely be the key for a higher PET degrading activity. Clearly, further investigation is needed to identify the best possible mutations to be engineered for more efficient enzymatic PET degradation.
