# Structurally versatile phosphine and amine donors constructed from N -heterocyclic olefin units $\dagger$

#### Abstract

A general strategy for the synthesis of hindered N - and P -based donors is presented whereby the strongly electron releasing N -heterocyclic olefin $(\mathrm{NHO})$ unit, $\mathrm{IPr}=\mathrm{CH}-$, ( $\mathrm{IPr}=\mathrm{CH}-=\left[(\mathrm{HCNDipp})_{2} \mathrm{C}=\mathrm{CH}\right]^{-}$; Dipp $=$ $3,6-{ }^{\prime} \mathrm{Pr}_{2} \mathrm{C}_{6} \mathrm{H}_{2}$ ) is linked to terminally bound phosphine and amine donors. Preliminary coordination chemistry is presented involving phosphine $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PR}_{2}\left(\mathrm{R}={ }^{i} \mathrm{Pr}\right.$ and Ph$)$ and amine $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2}$ ligands and the Lewis acids $\mathrm{BH}_{3}$ and AuCl . Interestingly, $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2}$ binds AuCl through an exocyclic olefin unit, while the softer phosphorus centers in $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PR}_{2}$ coordinate to yield Au-P linkages; thus the reported NHO-based ligands exhibit tunable binding modes to metals.

catalysts for various polymerization strategies, ${ }^{6}$ and as a component of pincer-type ligands. ${ }^{7}$

In this paper, we present efficient routes to phosphine and amine donors that contain an NHO moiety $[\mathrm{IPr}=\mathrm{CH}]^{-}$directly linked to P- and N-donor sites. As shown in Chart 2, there is a possibility of coordination through either the NHO (via carbon-ligation) or the terminal $\mathrm{P} / \mathrm{N}$ atoms. Our current study was motivated in part by the prior work of Beller who demonstrated that imidazolium-alkylphosphines (Chart 1; right) when combined with $\operatorname{Pd}($ II $)$ sources and base, afforded active catalysts (in situ) for the hydroxylation of arylhalides, and for both C-N (Buchwald-Hartwig) and C-C (Sonogashira) coupling reactions. ${ }^{8}$ Despite the possible formation of neutral NHO-linked phosphines (NHOPs; Chart 2; E = P) during Beller's catalytic processes, such ligands were not isolated, nor were any well-defined metal complexes with these ligands reported. As a result, we decided to explore this ligand class in more detail and consequently uncovered divergent coordination behavior towards AuCl, depending if hard amine- or soft-phosphine groups are appended to an NHO unit.

## Introduction

Sterically encumbered phosphines and N -heterocyclic carbenes (NHCs) are effective ligands for supporting a variety of catalytic bond-forming processes, ${ }^{1}$ and can stabilize highly reactive molecular entities via strong coordinative interactions. ${ }^{2}$ Common traits between these two ligand classes are the presence of a strongly $\sigma$-donating atom, ease of synthesis, and a high level of structural tunability. A related ligand group that is attracting increasing attention of late are N -heterocyclic olefins (NHOs), ${ }^{3}$ which contain considerable nucleophilic character due to the highly polarized nature of the exocyclic $\mathrm{C}=\mathrm{C}$ double bond, allowing these species to be strong neutral 2-electron donors (Chart 1; left). Accordingly, NHOs are now being used to intercept reactive inorganic species, ${ }^{4,5}$ as organo-

## Results and discussion

## Synthesis of N -heterocyclic olefin phosphines (NHOPs)

We began our studies by exploring the synthesis of the diiso-propylphosphine-capped N -heterocyclic olefin $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ 2 ( $\mathrm{IPr}=\left[(\mathrm{HCNDipp})_{2} \mathrm{C}\right] ;$ Dipp $\left.=2,6-{ }^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{C}_{6} \mathrm{H}_{3}\right)$. In line with prior work from our group, ${ }^{9}$ the readily available $\mathrm{NHO}, \mathrm{IPr}=\mathrm{CH}_{2}$ 1, ${ }^{3 d}$ was combined with $\mathrm{ClP}^{\mathrm{i}} \mathrm{Pr}_{2}$ in a $1: 1$ ratio in THF (Scheme 1) with the intention of first isolating the imidazolium salt $\left[\mathrm{IPr}-\mathrm{CH}_{2}-\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}\right] \mathrm{Cl}$, which would be isostructural to Beller's pre-ligands shown in Chart 1. While there was spectroscopic evidence for the formation of the desired imidazolium salt, the starting material $\mathrm{IPr}=\mathrm{CH}_{2} \mathbf{1}$ was sufficiently basic to deprotonate $\left[\mathrm{IPr}-\mathrm{CH}_{2}-\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}\right] \mathrm{Cl}$ to give 2 and the known byproduct $\left[\mathrm{IPrCH}_{3}\right] \mathrm{Cl} .{ }^{9}$ Fortunately 2 and $\left[\mathrm{IPrCH}_{3}\right] \mathrm{Cl}$ have quite different solubilities, allowing for their easy separation. By altering the ratio between $\mathrm{IPr}=\mathrm{CH}_{2} 1$ and $\mathrm{ClP}^{\mathrm{i}} \mathrm{Pr}_{2}$ to $2: 1$ (eqn (1)) and conducting the reaction in THF at room temperature for 20 h , we were able to isolate pure $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2$ in $81 \%$ yield after extracting 2 from the product mixture (containing $\left[\mathrm{IPrCH}_{3}\right] \mathrm{Cl}$ ) with hexanes. Following a similar procedure,

the phenyl-substituted NHOP $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2} 3$ was prepared in an isolated yield of $83 \%$ (eqn (1)). The new NHOPs 2 and 3 were each characterized by NMR spectroscopy, elemental analysis and X-ray crystallography (colorless crystals grown from hexanes at $-30^{\circ} \mathrm{C}$; Fig. 1 and 2).


The refined structure of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2$ is presented in Fig. 1 with only one of the four crystallographically-independent molecules in the unit cell shown; thus, selected bond lengths and angles are provided as a range. The exocyclic $\mathrm{C}=\mathrm{C}$ bonds in $2[\mathrm{C}(1)-\mathrm{C}(4)=1.364(4)$ to $1.366(4) \AA$ A are considerably shorter than the typical C-C single bond length of ca. $1.530 \AA,{ }^{10}$ and is only slightly elongated compared to the exocyclic $\mathrm{C}=\mathrm{C}$ bond length of $1.332(4) \AA$ in free $\mathrm{IPr}=\mathrm{CH}_{2} .{ }^{3 c}$ As expected, the crystallographically determined $\mathrm{C}\left(\mathrm{sp}^{2}\right)-\mathrm{P}$ linkages in $2[\mathrm{C}(4)-\mathrm{P}(1)=1.780(3)$ to $1.788(2) \AA]$ are contracted with respect to the $\mathrm{C}\left(\mathrm{sp}^{3}\right)-\mathrm{P}$ bonds involving the ${ }^{\mathrm{i}} \operatorname{Pr}$ substituents [1.835(4) to $1.896(4) \AA$ A . For comparison the $\mathrm{C}($ olefin) -P distances in cis $-\mathrm{Ph}_{2} \mathrm{P}-\mathrm{CH}=\mathrm{CH}-\mathrm{PPh}_{2}$ are 1.817(3) and 1.825(3) $\AA,{ }^{11}$ suggesting a possible increase in $\mathrm{C}(\pi) \rightarrow \mathrm{P}-\mathrm{C}\left(\sigma^{*}\right)$ hyperconjugation in 2, leading to shorter $\mathrm{C}\left(\mathrm{sp}^{2}\right)-\mathrm{P}$ bonds. The overall metrical parameters in $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2}$ (3) (Fig. 2) are quite similar to that of 2 with an average $\mathrm{C}(4)-\mathrm{P}(1)$ distance of $1.780(2) \AA$ in 3 and average $\mathrm{C}(1)-\mathrm{C}(4)-\mathrm{P}(1)$ angles of $126.0(2)^{\circ}$, compared to a range of $126.9(2)$ to $129.8(2)^{\circ}$ in 2.

Synthesis of the N -heterocyclic olefin amine $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$
In addition to preparing NHOPs, we wanted to see if a harder amine donor could be incorporated onto an NHO scaffold. The dimethylamino-substituted $\mathrm{NHO},(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$, was prepared by combining two equivalents of the commercially available carbene IPr with one equivalent of Eschenmoser's salt $\left[\mathrm{H}_{2} \mathrm{C}=\mathrm{NMe}_{2}\right] \mathrm{I}^{12}$ in toluene (eqn (2)). In this process, the first equivalent of IPr is believed to undergo a nucleophilic attack on the iminium moiety to form $\left[\operatorname{IPr}-\mathrm{CH}_{2}-\mathrm{NMe}_{2}\right] \mathrm{I}$ which is then subsequently deprotonated by a second equivalent of $\operatorname{IPr}$ to yield $(\operatorname{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$ and the imidazolium by-product $[\mathrm{IPrH}] \mathrm{I}$ (which can be recycled for the preparation of $\operatorname{IPr}$ ) (eqn (2)). In a similar fashion as the syntheses of 2 and 3 , the salt by-product $[\mathrm{IPrH}] \mathrm{I}$ is much less soluble than the target ligand 4 , thus separation could be achieved by filtering the reaction mixture. One drawback with this synthesis is that the crude samples of 4 occasionally contains $c a .5-10 \%$ of unreacted $\operatorname{IPr}$ (as determined by ${ }^{1} \mathrm{H}$ NMR $)$, which is difficult to separate from $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$ due to their similar solubilities in common organic solvents. However, a successful way to remove the IPr contaminant involves adding a small amount of $\mathrm{BPh}_{3}$ to form the known adduct $\mathrm{IPr} \cdot \mathrm{BPh}_{3},{ }^{13}$ which is much less soluble in hexanes than 4.


The structure of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$ was authenticated by X-ray crystallography (Fig. 3) and this study revealed an exocyclic C(1)-C(4) bond length of $1.3463(14) \AA$ which is slightly shorter than the corresponding distances in the NHOPs 2 and 3, suggesting the retention of substantial $\mathrm{C}-\mathrm{C} \pi$-bonding in this

unit. The $\mathrm{C}(1)-\mathrm{C}(4)-\mathrm{N}(1)$ angle was also consistent with $\mathrm{sp}^{2}$ hybridization at $\mathrm{C}(4)\left[122.98(9)^{\circ}\right]$, while the nitrogen atom of the $-\mathrm{NMe}_{2}$ group is significantly pyramidalized $\left[\Sigma^{\circ}(\mathrm{N})=333.35(17)^{\circ}\right]$ consistent with a lack of substantial $\mathrm{N}(3)-\mathrm{C}(4) \pi$-bonding.

## Coordination of the NHOPs 2 and 3 to $\mathrm{BH}_{3}$ and AuCl

With the new NHOPs in hand, we first tested their reactivity with the Lewis acid source THF $\cdot \mathrm{BH}_{3}$. When either $(\mathrm{IPr}=\mathrm{CH})$ $\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2$ or $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2} 3$ was combined with THF $\cdot \mathrm{BH}_{3}$ in hexanes (eqn (3)), the reaction mixture went from yellow to colorless after 90 min at room temperature. After the volatiles were removed, the respective phosphine-borane adducts $(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} 5$ and $(\mathrm{IPr}=\mathrm{CH}) \mathrm{Ph}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} 6$ were isolated as colorless crystals in 52 and $56 \%$ yields after recrystallization from cold $\left(-30{ }^{\circ} \mathrm{C}\right)$ hexanes or toluene (slow evaporation), respectively. As expected, coordination of a $\mathrm{BH}_{3}$ unit was evident by NMR spectroscopy, which showed broad ${ }^{11} \mathrm{~B}$ NMR resonances at -42.0 and -35.8 ppm for 5 and $\mathbf{6}$, respectively, consistent with the presence of four-coordinate boron environments. In addition, considerable downfield shifts in the ${ }^{31} \mathrm{P}$ resonances were noted within the NHOPs upon $\mathrm{BH}_{3}$ coordination: from -17.4 ppm in 2 to 21.9 ppm in $(\mathrm{IPr}=$ $\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} 5$; from -31.4 ppm in 3 to 7.3 ppm in $(\mathrm{IPr}=\mathrm{CH})-$ $\mathrm{Ph}_{2} \mathrm{P} \cdot \mathrm{BH}_{3}$ 6. Such a substantial change in ${ }^{31} \mathrm{P}$ NMR chemical shift indicated the likely presence of $\mathrm{BH}_{3}$ units bound to the phosphorus centers; this postulate was confirmed by performing single-crystal X-ray crystallography (5: Fig. 4; 6: Fig. 5).

As shown in Fig. 4, $(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} 5$ contains a P-bound borane residue with a P-B bond length of 1.9166(18) $\AA$; for comparison, the dialkylphosphine-borane adduct ${ }^{t} \mathrm{Bu}_{2} \mathrm{PH} \cdot \mathrm{BH}_{3}$ has a P-B bond length of 1.936(2) $\AA .{ }^{14}$ In the case of $(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} 5$, the $\mathrm{P}(1)-\mathrm{C}(4)$ length [1.7504(14) $\AA$ ] is contracted in comparison to the corresponding distance in the free phosphine $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2[1.780(3)$ to $1.788(2) \AA]$. exocyclic $\mathrm{C}(1)-\mathrm{C}(4)$ double bond within the NHO unit in 5 $[1.3749(18) \AA]$ is essentially the same length within experimental error as the exocyclic $\mathrm{C}=\mathrm{C}$ bond distances in the phosphine 2 [1.364(4) to $1.366(4) \AA$. $]$. The main structural change noted upon coordination of $\mathrm{BH}_{3}$ is a widening of the $\mathrm{P}-\mathrm{C}(4)-$ $\mathrm{C}(1)$ from $126.9(2)^{\circ}$ in the free ligand 2 to $138.02(11)^{\circ}$ in adduct 5. Similarly, the $\mathrm{P}-\mathrm{C}(4)-\mathrm{C}(1)$ angle in the phenyl analogue $(\mathrm{IPr}=\mathrm{CH}) \mathrm{Ph}_{2} \mathrm{P} \cdot \mathrm{BH}_{3}(\mathbf{6})\left[138.31(9)^{\circ}\right]$ (Fig. 5) is wider than in the free phosphine $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2}$ (3) [126.0(2) ${ }^{\circ} \mathrm{avg}$.]. In both compounds 5 and 6, the $\mathrm{BH}_{3}$ unit is oriented in an anti-fashion with respect to the exocyclic olefinic $\mathrm{C}-\mathrm{H}$ group, placing the $\mathrm{BH}_{3}$ group in close proximity to one of the flanking Dipp aryl groups of the NHO ligand; such a coordination mode could enhance aryl $\cdots$ metal interactions within NHOP-metal complexes. ${ }^{1 e}$


After demonstrating the successful coordination of the small Lewis acid $\mathrm{BH}_{3}$ to the NHOPs 2 and 3, we decided to expand our studies to include transition metals. Our initial explorations focused on the noble metals Pd and Pt since complexes bearing these elements in conjunction with bulky phosphines ${ }^{15}$ and NHCs ${ }^{16}$ are often used in metal-mediated crosscoupling reactions. Despite the presence of a potentially strongly coordinating terminal $-\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ unit in $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2$, no discernable reaction was noted when excess 2 (2-3 equiv.) was combined with either $\operatorname{Pd}\left(\mathrm{PPh}_{3}\right)_{4}$ or $\mathrm{Pt}\left(\mathrm{PPh}_{3}\right)_{4}$ in hot $\mathrm{C}_{6} \mathrm{D}_{6}$ ( $50{ }^{\circ} \mathrm{C}$ ) for 4 days (monitored by ${ }^{31} \mathrm{P}$ NMR spectroscopy). A similar lack of reactivity was found with the two coordinate $\mathrm{Pt}(0)$ complex $\mathrm{Pt}\left(\mathrm{P}^{\mathrm{t}} \mathrm{Bu}_{3}\right)_{2}$. Attempts to form a bis NHOP- $\mathrm{PdCl}_{2}$
pre-catalyst ${ }^{17}$ by treating $\mathrm{PdCl}_{2}(\mathrm{NCPh})_{2}$ with two equiv. of 2 in toluene, led to an immediate color change of the reaction mixture from yellow to dark red, however ${ }^{31} \mathrm{P}$ NMR analysis revealed the formation of six spectroscopically distinct products from which a single clean product could not be isolated.

Reports of using $[\mathrm{PdCl}(\text { cinnamyl })]_{2} \quad$ (cinnamyl $=\eta^{3}$ $\left.\mathrm{H}_{2} \mathrm{CCHCH}(\mathrm{Ph})\right)$ as a palladium source to generate active $\mathrm{L} \cdot \mathrm{Pd}-$ (cinnamyl) pre-catalysts ( $\mathrm{L}=$ ligand $)^{18}$ in cross-coupling reactions led us to combine $[\mathrm{PdCl}(\text { cinnamyl })]_{2}$ with $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ 2. When 2 was mixed with $[\operatorname{PdCl}(\text { cinnamyl })]_{2}$ in toluene several new species were found by ${ }^{31} \mathrm{P}$ NMR spectroscopy. In one case, layering of the crude reaction mixture with hexanes, followed by cooling to $-30{ }^{\circ} \mathrm{C}$ gave a small batch of yellow crystals ( $2-3 \mathrm{mg}$ ) that were identified by X-ray crystallography as the target $\mathrm{Pd}(\mathrm{II})$ complex $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} \cdot \mathrm{PdCl}($ cinnamyl) 7 (Fig. 6).

Upon closer inspection of the structure of 7 (Fig. 6) it is clear that the $-\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ unit is free to rotate with respect to the bulky $\mathrm{IPr}=\mathrm{CH}$ - group. In the $\mathrm{BH}_{3}$ adduct 5 , the isopropropyl groups are rotated away from the IPr unit, while in $(\operatorname{IPr}=\mathrm{CH})$ $\mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} \cdot \mathrm{PdCl}($ cinnamyl $) 7$ the phosphorus bound ${ }^{\mathrm{i}} \mathrm{Pr}$ substituents are positioned toward one Dipp group, enabling the more hindered $\mathrm{PdCl}($ cinnamyl $)$ array to occupy a more open side of the NHOP ligand coordination sphere. Therefore despite the bulk of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$, there exists sufficient torsional flexibility to allow different coordination pockets to be formed (a useful property for catalysis when various intermediates need to be stabilized). The Pd-cinnamyl bonding interactions in 7 range from $2.113(6) \AA$ to $2.261(5) \AA$ with the longest Pd-C bond to $\mathrm{C}(53)$ positioned trans to the phosphine donor. In the NHC complex $\operatorname{IPr} \cdot \operatorname{PdCl}($ cinnamyl $)$, the related trans-positioned $\mathrm{Pd}-\mathrm{C}$ bond length (with respect to the IPr donor) is $2.201(17) \AA,{ }^{19}$ indicating that the ligand $(\operatorname{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ exerts a similar degree of trans-influence as IPr.

Given the difficulties faced in introducing an NHOP as a ligand to Pd and Pt centers, we decided the explore the coordi-

nation of this ligand class to gold(I) centers. Added motivation for this work stems from the rapidly growing use of $\mathrm{Au}(\mathrm{I})$ complexes in catalysis (e.g. in the hydroamination of alkynes). ${ }^{20} \mathrm{~A}$ toluene solution of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2} 2$ was added to a molar equivalent of $\mathrm{Me}_{2} \mathrm{~S} \cdot \mathrm{AuCl}$, and after stirring at room temperature for $2 \mathrm{~h},(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{AuCl} 8$ was obtained as a pale yellow solid in an $85 \%$ yield after filtration of the reaction mixture and removal of the volatiles (eqn (4)); the resulting product was analytically pure as judged by satisfactory C, H and N analyses. Compound 8 was characterized by X-ray crystallography and the refined molecular structure is shown in Fig. 7. The metrical parameters within the $\mathrm{IPr}=\mathrm{CH}-$ unit in 8 are similar to those in the $\mathrm{BH}_{3}$ adduct $(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P} \cdot \mathrm{BH}_{3} \mathbf{5}$, with comparable $\mathrm{P}-\mathrm{C}(4)$ and exocyclic $\mathrm{C}(1)-\mathrm{C}(4)$ bond lengths [1.7742(19) and $1.376(3) \AA$, respectively]. Interestingly, the ${ }_{-} \mathrm{P}^{\mathrm{i}} \mathrm{Pr}_{2}$ unit in $\mathbf{8}$ is rotated in such as fashion as to place the hindered isopropyl groups away from the Dipp groups within the $\mathrm{IPr}=\mathrm{CH}$ - unit; as a result the $\mathrm{Au}(\mathrm{I})$ center lies over the $\pi$-face of a Dipp substituent ( $\mathrm{Au} \cdots \mathrm{C}($ ipso $)$ distance $=3.507 \AA$ ), and accordingly the $\mathrm{P}-\mathrm{Au}-\mathrm{Cl}$ angle $\left[171.40(2)^{\circ}\right]$ is distorted from the expected linear geometry. For comparison, shorter arene $\cdots \mathrm{Au}(\mathrm{I})$ interactions have been noted within a series of Buchwald biarylphosphine-Au(I) complexes $\quad \mathrm{L} \cdot \mathrm{Au}(\mathrm{NCMe})^{+}$ (3.04-3.19 $\AA$ )..$^{21}$ The corresponding diphenylphosphine-capped NHO complex $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2} \cdot \mathrm{AuCl} 9$ was prepared ( $98 \%$ yield) in a similar straightforward manner as $\mathbf{8}$, and exhibited the same overall geometry as in 8 (Fig. 8) with a slightly narrower $\mathrm{P}-\mathrm{Au}-\mathrm{Cl}$ angle of $168.72(4)^{\circ}$.

In an attempt to prepare a more reactive $\mathrm{Au}(\mathrm{I})$ complex for future catalytic trials, ${ }^{20 d}$ the $\mathrm{NHO}-\mathrm{Au}$ complex ( $\mathrm{IPr}=\mathrm{CH}$ )$\mathrm{Ph}_{2} \mathrm{P} \cdot \mathrm{AuCl} 9$ was treated with $\mathrm{Na}\left[\mathrm{BAr}^{\mathrm{F}}{ }_{4}\right]\left(\left[\mathrm{BAr}_{4}{ }_{4}\right]^{-}=(3,5-\right.$ $\left.\left.\left(\mathrm{F}_{3} \mathrm{C}\right)_{2} \mathrm{C}_{6} \mathrm{H}_{3}\right)_{4} \mathrm{~B}\right)$ in toluene. This reaction afforded a gummy orange precipitate from which a product of $\left[\mathrm{BAr}_{4}{ }_{4}\right]^{-}$anion activation $\left[\mathrm{IPr}-\mathrm{CH}_{2}-\mathrm{PPh}_{2} \cdot \mathrm{Au}\left(3,5-\left(\mathrm{F}_{3} \mathrm{C}\right)_{2} \mathrm{C}_{6} \mathrm{H}_{3}\right)\right] \mathrm{BAr}^{\mathrm{F}} 40$ could be isolated and structurally characterized (eqn (5); Fig. 9). While the mechanism of this process is under investigation, protonation of the exocyclic olefin within the NHO unit occurred to yield an imidazolium-alkylphosphine ligand, ${ }^{8}$ along with the removal of one $\mathrm{Ar}^{\mathrm{F}}$ unit from the generally unreactive weakly coordinating $\left[\mathrm{BAr}_{4}{ }_{4}\right]^{-}$anion. One possible source of the proton would be $\mathrm{C}-\mathrm{H}$ activation of the backbone olefin within the IPr unit. ${ }^{22}$ The generation of a highly electron deficient $\operatorname{Au}(\mathrm{I})$ center during the reaction process could facilitate the abstraction of $\mathrm{Ar}^{\mathrm{F}}$ from the $\left[\mathrm{BAr}^{\mathrm{F}}\right]^{-}$anion; although rare, related pro-

cesses have been noted with both phosphine and NHC-bound $\mathrm{Au}(\mathrm{I})$ centers. ${ }^{23}$ The structure of $\mathbf{1 0}$ is shown in Fig. 9 and, as expected, a nearly linear coordination geometry exists at the $\mathrm{Au}(\mathrm{I})$ center $\left[\mathrm{P}-\mathrm{Au}-\mathrm{C}(71)\right.$ angle $\left.=174.82(11)^{\circ}\right]$. The coordinative $\mathrm{Au}-\mathrm{P}$ interaction in $\mathbf{1 0}$ [2.2798(8) $\AA]$ is only marginally elongated in relation to the $\mathrm{Au}-\mathrm{P}$ distance in $(\mathrm{IPr}=\mathrm{CH})^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{P}$. AuCl 8 [2.2348(5) A], while the adjacent $\mathrm{P}-\mathrm{C}(4)$ bond length in 10 is longer by ca. $0.12 \AA$ when compared to the $\mathrm{P}-\mathrm{C}(4)$ distance in 8 as a result of a hybridization change at carbon from $\mathrm{sp}^{2}$ in 8 to $\mathrm{sp}^{3}$ in $\mathbf{1 0}$. No reaction was observed when $(\mathrm{IPr}=\mathrm{CH})$ $\mathrm{Ph}_{2} \mathrm{P} \cdot \mathrm{AuCl} 9$ was treated with $\mathrm{Na}\left[\mathrm{SbF}_{6}\right]$.


To further evaluate the donation abilities of the new phosphines, we targeted the preparation of NHOP $\cdot \mathrm{Rh}(\mathrm{CO})_{2} \mathrm{Cl}$ complexes with the hope of obtaining informative $\nu(\mathrm{CO})$ IR data. ${ }^{3 d}$ When the NHOPs 2 and 3 were each combined with 0.5 equiv. of $\left[\mathrm{RhCl}(\mathrm{CO})_{2}\right]_{2}$, three different $\mathrm{Rh}-\mathrm{P}$ containing products were found, as evidenced by ${ }^{31} \mathrm{P}\left\{{ }^{1} \mathrm{H}\right\}$ NMR spectroscopy in the form of doublet resonances due to coupling to $\mathrm{Rh}(I=1 / 2)$. Despite multiple attempts, we could not separate the products due to their similar solubilities in common organic solvents, and as such further investigations were not pursued.

## Divergent coordination chemistry of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$

As presented above, the NHOPs 2 and 3 exclusively bind to Lewis acidic units through the terminal phosphine residues. However in the corresponding amine-capped NHOs (such as 4) featuring hard N -donor sites, there exists a chance that olefin coordination could transpire with soft Lewis acids (Chart 1). Somewhat to our surprise, $(\operatorname{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$ did not yield clean reactivity with THF• $\mathrm{BH}_{3}$, with multiple products identified by ${ }^{11} \mathrm{~B}$ NMR spectroscopy. In contrast, an isolable $1: 1$ complex $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} \cdot \mathrm{AuCl} 11$ formed as a yellow solid in $89 \%$ yield when 4 was combined with $\mathrm{Me}_{2} \mathrm{~S} \cdot \mathrm{AuCl}$ in toluene (eqn (6)). The most drastic change in the ${ }^{13} \mathrm{C}\left\{{ }^{1} \mathrm{H}\right\}$ NMR spectra of the $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2}$ units was the upfield shift of the olefinic $C \mathrm{HNMe}_{2}$ carbon from 89.0 ppm in free $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} 4$ to a position of 58.4 ppm in 11; this latter spectroscopic signature suggested possible olefin coordination to gold in 11. Crystals of 11 were obtained for X-ray crystallographic analysis and despite the lower quality of the data, $(\operatorname{IPr}=\mathrm{CH}) \mathrm{NMe}_{2}$ coordination through a C-Au linkage was confirmed with a distance of $2.044(15) \AA$; moreover a nearly linear geometry was present at gold $\left[\mathrm{C}(3)-\mathrm{Au}-\mathrm{Cl}\right.$ angle $=177.6(4)^{\circ}$; see Fig. S 32 in the ESI $\dagger$ ]. Therefore one can see direct evidence for the two possible binding modes of NHO-supported amines and phosphines in this study (Chart 2).


## Conclusion

We have reported efficient syntheses of neutral N -heterocyclic olefin-appended phosphines and amine donors, and present preliminary coordination behavior with the Lewis acids $\mathrm{BH}_{3}$ and AuCl. Interestingly, modulation of the donor properties enables either NHO-based coordination (via an olefinic carbon atom) or standard phosphine binding modes to be adopted. As a result, we are exploring these coordinatively versatile ligands within the context of late metal-mediated catalysis.

## Experimental

## General

All reactions were performed in either an inert atmosphere glove box (Innovative Technology, Inc.) or using Schlenk techniques. Solvents were dried using a Grubbs-type solvent purification system ${ }^{24}$ manufactured by Innovative Technologies, Inc. and stored under an atmosphere of nitrogen prior to use. Chlorodiisopropylphosphine, chlorodiphenylphosphine, $\mathrm{N}, \mathrm{N}$-dimethyliminium iodide ( $\left[\mathrm{Me}_{2} \mathrm{~N}=\mathrm{CH}_{2}\right] \mathrm{I}$ ), borane tetrahydrofuran complex, dimethylsulfide gold(I) chloride, $\mathrm{Na}\left[\mathrm{SbF}_{6}\right]$, and $[\mathrm{PdCl}$ (cinnamyl) $]_{2}$ were used as received from Sigma Aldrich. $\mathrm{Na}[(3,5-$ $\left.\left.\left(\mathrm{F}_{3} \mathrm{C}\right)_{2} \mathrm{C}_{6} \mathrm{H}_{3}\right)_{4} \mathrm{~B}\right]$ was obtained from Sigma Aldrich and dried under vacuum at $100{ }^{\circ} \mathrm{C}$ for 12 h prior to use. $\mathrm{IPr}=\mathrm{CH}_{2} \mathbf{1}^{3 d}$ and $\mathrm{IPr}^{25}$ were prepared according to literature procedures. ${ }^{1} \mathrm{H}$, ${ }^{1} \mathrm{H}\left\{{ }^{31} \mathrm{P}\right\},{ }^{13} \mathrm{C}\left\{{ }^{1} \mathrm{H}\right\},{ }^{31} \mathrm{P}\left\{{ }^{1} \mathrm{H}\right\},{ }^{11} \mathrm{~B}$, and ${ }^{11} \mathrm{~B}\left\{{ }^{1} \mathrm{H}\right\}$ NMR spectra were recorded on a Varian VNMRS-400 or Varian VNMRS-500 spectrometer and referenced externally to $\mathrm{SiMe}_{4}, 85 \% \mathrm{H}_{3} \mathrm{PO}_{4}$, or $\mathrm{F}_{3} \mathrm{~B} \cdot \mathrm{OEt}_{2}$. Elemental analyses were performed by the Analytical and Instrumentation Laboratory at the University of Alberta. Melting points were measured in sealed glass capillaries under nitrogen using a MelTemp melting point apparatus and are uncorrected.

## X-ray crystallography

Crystals for X-ray diffraction studies were removed from a vial and immediately coated with thin a layer of hydrocarbon oil (Paratone-N). A suitable crystal was then mounted on a glass fiber, and quickly placed in a low temperature stream of nitrogen on the X-ray diffractometer. All data (Tables 1 and 2) were collected using a Bruker APEX II CCD detector/D8 diffractometer using Mo $\mathrm{K} \alpha$ or $\mathrm{Cu} \mathrm{K} \alpha$ radiation with the crystals cooled to $-80{ }^{\circ} \mathrm{C}$ or $-100{ }^{\circ} \mathrm{C}$. The data was corrected for absorption through Gaussian integration from the indexing of the crystal faces. Crystal structures were solved using intrinsic phasing SHELXT $^{26}$ (2, 4, 5, 6, 9 and 11), direct methods (3), or Patterson/ structure expansion (7 and 8) ${ }^{27}$ and refined using full-matrix

least-squares on $F^{2}$. The assignment of hydrogen atoms positions were based on the $\mathrm{sp}^{2}$ or $\mathrm{sp}^{3}$ hybridization of their attached carbon atoms, and were given thermal parameters $20 \%$ greater than those of their parent atoms.

## Special refinement conditions

$(\mathbf{I P r}=\mathbf{C H}) \mathbf{P}^{\mathbf{i}} \mathbf{P r}_{2} \cdot \mathbf{B H}_{\mathbf{3}} \mathbf{5}$. Attempts to refine peaks of residual electron density as disordered or partial-occupancy solvent hexane carbon atoms were unsuccessful. The data were cor-
rected for disordered electron density through use of the SQUEEZE procedure as implemented in PLATON. ${ }^{28}$ A total solvent-accessible void volume of $1145 \AA^{3}$ with a total electron count of 212 (consistent with 4.24 molecules of solvent hexane, or $\sim 0.25$ molecules per formula unit of 5 ) was found in the unit cell.
$(\mathbf{I P r}=\mathbf{C H}) \mathbf{P}^{\mathbf{i}} \mathbf{P r}_{2} \cdot \mathbf{P d C l}($ cinnamyl) 7 . The crystal used for data collection was found to display non-merohedral twinning. Both components of the twin were indexed with the program CELL_NOW (Bruker AXS, Inc., Madison, WI, 2004). The second twin component can be related to the first component by a $7.4^{\circ}$ rotation about the $[0.21-0.35]$ axis in real space and about the $[0.11-0.4]$ axis in reciprocal space. Integrated intensities for the reflections from the two components were written into a SHELXL-2014 ${ }^{26}$ HKLF 5 reflection file with the data integration program SAINT (version 8.34A), using all reflection data (exactly overlapped, partially overlapped and non-overlapped). The refined value of the twin fraction (SHELXL-2014 BASF parameter) was $0.3198(17)$.

Attempts to refine peaks of residual electron density as disordered or partial-occupancy solvent toluene or hexane carbon atoms were unsuccessful. The data were corrected for disordered electron density through use of the SQUEEZE procedure as implemented in PLATON. ${ }^{28}$ A total solvent-accessible void volume of $517 \AA^{3}$ with a total electron count of 110 (consistent with 2 molecules of solvent toluene, or 0.5 molecules per formula unit of the Au complex) was found in the unit cell.

## Synthetic details

Synthesis of $(\mathbf{I P r}=\mathbf{C H}) \mathbf{P}^{\mathbf{i}} \mathbf{P r}_{2} 2 .{ }^{\mathrm{i}} \mathrm{Pr}_{2} \mathrm{PCl}(100 \mu \mathrm{~L}, 0.77 \mathrm{mmol})$ was added dropwise to $\mathrm{IPr}=\mathrm{CH}_{2} 1(0.508 \mathrm{~g}, 1.26 \mathrm{mmol})$ in 8 mL of THF. The resulting mixture was stirred for 20 h to give an orange suspension. The mixture was then filtered and the volatiles were removed from the filtrate to afford an orange solid that was extracted with 4 mL of hexanes and filtered again. Removal of the volatiles from the filtrate gave 2 as a light brown solid ( $0.267 \mathrm{~g}, 81 \%$ ). Synthesis of $(\mathbf{I P r}=\mathbf{C H}) \mathbf{P P h}_{\mathbf{2}} \mathbf{3} . \mathrm{Ph}_{2} \mathrm{PCl}(41.2 \mu \mathrm{~L}, 0.16 \mathrm{mmol})$ was added dropwise to a solution of $\mathrm{IPr}=\mathrm{CH}_{2} \mathbf{1}(0.150 \mathrm{~g}$, 0.37 mmol ) in 3 mL of THF. The resulting mixture was stirred overnight to give an orange suspension. The precipitate was allowed to settle and the mother liquor was isolated after filtration. The volatiles were removed from the mother liquor to afford $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2} 3$ as a brown solid ( $0.078 \mathrm{~g}, 83 \%$ ). Synthesis of $\mathrm{IPr}=\mathrm{CHNMe}_{2}$ 4. A solution of $\operatorname{IPr}(0.481 \mathrm{~g}$, 1.24 mmol ) in 3 mL of toluene was added to finely ground $\left[\mathrm{H}_{2} \mathrm{C}=\mathrm{N}\left(\mathrm{CH}_{3}\right)_{2}\right] \mathrm{I}(0.115 \mathrm{~g}, 0.62 \mathrm{mmol})$. The resulting mixture was stirred overnight to give a cloudy yellow reaction mixture. The mother liquor was isolated after filtration. The volatiles were then removed from the mother liquor to afford a yellow solid that was extracted with 2 mL of hexanes and filtered. Removal of the volatiles from the filtrate afforded 4 as a yellow solid ( 227 mg , 82\%, product also contained $7 \%$ of unreacted IPr ). Further purification can be performed by adding $\mathrm{BPh}_{3}$ (ca. 2 mg ) to $4(0.050 \mathrm{~g})$ in minimal amount of benzene (ca. 0.5 mL ). The solution was stirred for 15 min and 2 mL of hexanes was added to yield a white precipitate. The mother liquor was isolated after filtration and the volatiles were removed from the filtrate to afford $4(0.040 \mathrm{~g})$ containing $<1 \%$ of unreacted IPr. Preparation of $(\mathbf{I P r}=\mathbf{C H}) \mathbf{P P h}_{2} \cdot \mathbf{B H}_{3}$ 6. $93.8 \mu \mathrm{~L}$ of $\mathrm{THF} \cdot \mathrm{BH}_{3}$ ( 1.0 M solution in THF, 0.094 mmol ) was added dropwise to a solution of $\mathrm{IPr}=\mathrm{CHPPh}_{2} 3(50.0 \mathrm{mg}, 0.085 \mathrm{mmol})$ in 2 mL of hexanes. Reaction of $\mathrm{IPr}=\mathrm{CHNMe}_{2}$ with THF-BH $\mathbf{H}_{3} .63 .8 \mu \mathrm{~L}$ of THF $\cdot \mathrm{BH}_{3}(1.0 \mathrm{M}$ solution in THF, 0.058 mmol$)$ was added dropwise to a solution of $\mathrm{IPr}=\mathrm{CHNMe}_{2} 4(26 \mathrm{mg}, 0.058 \mathrm{mmol})$
in 1 mL of hexanes. Once THF• $\mathrm{BH}_{3}$ was added the yellow solution became colorless. This reaction mixture was stirred at room temperature for 2 hours and a small amount of metallic precipitate was observed. Synthesis of $(\mathbf{I P r}=\mathbf{C H}) \mathbf{P P h}_{2} \cdot \mathbf{A u C l} 9$. A solution of $(\mathrm{IPr}=\mathrm{CH})$ $\mathrm{PPh}_{2} 3(78 \mathrm{mg}, 0.13 \mathrm{mmol})$ in 5 mL of toluene was slowly
added to solid $\mathrm{Me}_{2} \mathrm{~S} \cdot \mathrm{AuCl}(40 \mathrm{mg}, 0.14 \mathrm{mmol})$ to give a yellow solution. This reaction mixture was stirred at room temperature for 90 minutes and a small amount of metallic precipitate was observed. The mixture was filtered and the volatiles were then removed from the filtrate to afford $(\mathrm{IPr}=\mathrm{CH}) \mathrm{PPh}_{2} \cdot \mathrm{AuCl} 9$ as a pale yellow solid ( $108 \mathrm{mg}, 98 \%$ ). Synthesis of $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} \cdot \mathrm{AuCl}$ 11. A solution of $\mathrm{IPr}=\mathrm{CHNMe}_{2} 4(98 \mathrm{mg}, 0.22 \mathrm{mmol})$ in 5 mL of toluene was added dropwise to solid $\mathrm{Me}_{2} \mathrm{~S} \cdot \mathrm{AuCl}(65 \mathrm{mg}, 0.22 \mathrm{mmol})$ to give
a dark yellow reaction mixture. This reaction mixture was stirred at room temperature for 90 minutes and a metallic precipitate was observed. The reaction mixture was then filtered and the volatiles were then removed from the filtrate to afford $(\mathrm{IPr}=\mathrm{CH}) \mathrm{NMe}_{2} \cdot \mathrm{AuCl}$ as a pale yellow solid ( $133 \mathrm{mg}, 89 \%$ ).
